ROADMASTERS REPORT

Kenneth Stoudt presented the February's Roadmaster's report.

ENGINEER – Mr. McMullen presented the following report:

1. Ontelaunee Drive and SR 0073 Intersection

To date we have not received notification regarding the status of the ARLE Grant application for the intersection improvements. It is perceived that notifications will not occur until a State budget is in-place.

2. Roads

March 3, 2016

The application for the Mohrsville Road Storm Sewer and Road Project was forwarded to the PUC for their approval. All interested parties (Township, County, Utilities, PennDOT, etc.) were notified of the application to the PUC.

Revisions were forwarded to the Berks Conservation District as requested for the GP-4 Permit (Outfall Structure).

3. <u>General Engineering</u>

- a. ARRO reiterated our previous comments to Ashley Furniture and their consultants that we and the Supervisors would like to have some better understanding of what actually is occurring during rain events and how downsizing or removing the basin/dam would impact stormwater runoff in the future. The need to provide an escrow fund for the review of any proposal/calculations for downsizing or removal of the dam was forward to Ashley via e-mail.
- b. ARRO was contacted by a consultant for Berks Products regarding the desire to rezone a portion of a parcel from A-1 to GI and a portion of a parcel from GI to C west of SR 0061 and south of Berks Products Drive. We recommended that information regarding the proposal be presented to the Board of Supervisors at their meeting on March 3, 2016.
- c. A determination was made, following input from Solicitor Magovern and Zoning Officer Michael Schwenk, that a land development plan would be required for the Dane Miller structure. Land development plans are required due to a portion of the proposed structure being utilized as a commercial gym.

4. Willow Glen

An improvement installation inspection report is attached.

5. Beechwood Subdivision

Improvement installation inspections were conducted for the Lot #3 infiltration bed. The infiltration bed is being installed pursuant to the approved subdivision plan.

6. Ryder Land Development Plan

Conditional preliminary plan approval was recommended by the Ontelaunee Township Planning Commission at their meeting of February 18, 2016. The plan is before the Supervisors at their meeting of March 3, 2016 for action. The review period for the submission expires March 31, 2016.

Ryder representatives have submitted documents to approving agencies (Ontelaunee PC, Berks PC, OTMA, LBA, Etc.) regarding the approval of a Component 3 Sewage Facilities Planning Module. We are aware of receipt of the responses for all agencies except LBA as the treatment facility owner/operator.

If desired, the Supervisors can conditionally approve the Component 3 Sewage Facilities Planning Module by approval of a Resolution pending the receipt and our favorable review of the completed module package.

March 3, 2016

The Ryder consultant (Bill Kovach of Osborn Engineering) was informed via email that the escrow deposit fund for the Ryder development review requires replenishing.

Discussion was held regarding the area on Ashley Way in the Sheetz area and Redner's entrance etc. Arro was asked to look at that area for line striping configuration to see what could be done to make it safer and more efficient. A motion was made by Gary Hadden and seconded by Kenneth Stoudt to have Arro look at this line striping configuration with the cost not exceed \$1,200. Vote 3:0

SOLICITOR – Nothing at this time, we will need to have an executive session after the meeting to discuss possible litigation.

CODE ENFORCEMENT – Mike Schwenk presented his report.
