### **BUSINESS FROM FLOOR**

There were numerous residents at the meeting to ask some questions regarding the Allan Myers asphalt plant that is proposed on Leesport Avenue.

Their concerns are the noise, the smell and truck traffic that could impact the Willow Glen development.

The supervisors understood their concerns and are empathetic to their positions, however, the site for the plant is in an industrial district and the development is meeting all zoning regulations.

As far as the noise and light issues, the township does have ordinances that the plant will have to adhere too. In addition, as far as the smell is concerned, this development will be regulated by the State and Federal government and will have to adhere to their policies as well. It was stated that the lighting for the asphalt plant will be lower than the lighting that is currently at the UGI plant.

The Supervisors will be taking a tour of the state of the art plant in Paradise, Lancaster County. This plant in Lancaster County will be the model that the plant in Ontelaunee will be modeled after.

One of the residents was also concerned about the truck traffic driving thru the development.

The township will post some signs that there is no truck traffic except local deliveries. In order to enforce it, the Township will have to create an ordinance.

Solicitor Magovern stated that there is a County comprehensive plan that was developed and anyone is welcome to come to the office and review it.

Solomon Lausch – Library representative, was present to thank the supervisors for their support of the Library and to ask again for support for 2019.

#### **ENGINEER'S REPORT – OCTOBER 2018**

### 1. Five Star International

A preliminary/final land develop plan has been received for review at the Ontelaunee Township Planning Commission meeting scheduled for November 15, 2018. Action on this plan is due on or before February 12, 2019 by the Ontelaunee Township Board of Supervisors.

### 2. Allan Myers Land Development

A preliminary/final land develop plan was conditionally approved at the Ontelaunee Township Planning Commission meeting held October 18, 2018.

Recommended action regarding the Supervisors conditional approval of the plan is listed on the meeting agenda.

### 3. Rutter's

The preliminary/final plan submission was reviewed and tabled at the September 20, 2018 Planning Commission meeting. A revised plan was received and will be reviewed at the November 15, 2018 Planning Commission meeting. Action on this plan is due on or before December 18, 2018 by the Ontelaunee Township Board of Supervisors.

Recommendation for approval of the Sewage Facilities Planning Module is listed on the meeting agenda.

We were informed that a subdivision plan for the Rutter's parcel from the Greater Berks Development Fund parcel will be provided pending resolution of right-of-way items.

## 4. <u>UGI – Berkshire Mechanical Land Development Plan</u>

A final plan was received for the project and will first be reviewed at the Ontelaunee Township Planning Commission at their meeting to be held November 15, 2018. Action on this plan is due on or before February 12, 2019 by the Ontelaunee Township Board of Supervisors.

## 5. Greater Berks Development Fund (GBDF) Rezoning

The proposed Zoning Map revision ordinance and exhibit was presented to the Ontelaunee Township Planning Commission at their September 20<sup>th</sup> meeting. The Planning Commission recommended the revisions as proposed. A public hearing for the proposed rezoning is listed on the meeting agenda.

## 6. <u>Brassler Parcel (Berks 222) Land Development Plan</u>

At their meeting of March 1, 2018 the Board of Supervisors granted Preliminary/Final Conditional Approval upon obtaining a PennDOT HOP permit for the Driveway Access on Allentown Pike, a stormwater HOP permit for discharge on East Huller Lane, enter into agreement with the township for the storm water maintenance of the facilities on East Huller Lane, final approval from Muhlenberg Township and addressing the remaining comments in the ARRO review correspondence dated Feb. 15, 2018.

The developer's consultant has provided an improvement cost estimate and the final revised plans. We are currently reviewing the estimate and plans. Preliminary comments and a request for missing plan sheets have been forwarded to the developer's consultant. The improvement cost estimate splits the improvements as 30% within Ontelaunee Township and 70% within Muhlenberg Township. Following review and approval of the cost estimate and plans we will forward our recommendation to Attorney Magovern's office for the preparation of the required Improvement and Stormwater agreements.

### 7. Perdue Driver Depot Land Development Plan

At their meeting held April 5, 2018, the Board of Supervisors provided Preliminary/Final Conditional Approval based on satisfying the conditions in the ARRO review correspondence of March 13, 2018 and executing a sewer capacity agreement.

Attorney Magovern's office revised the project agreements (Improvement & Stormwater Maintenance) as requested by the developer's Attorney and forwarded them along with the Sewer Capacity Agreement to the developer on September 14, 2018. To date we are not aware of the agreements and escrow being received by the Township.

Revised plans have been provided to the Township for signature by the Planning Commission and Board of Supervisors; however, the plans should not be released to the developer for recording until the agreements and escrow are received.

## 8. Reading-Berks Storage LLC (19 Willow Creek Land Development Plan)

The Ontelaunee Township Supervisors granted conditional approval of the Final Plan submission. The conditions of approval were receipt of an NPDES approval, Improvement Agreement, Stormwater Operations & Maintenance Agreement and submission of fully executed final plans.

To date we have not received documents required by the conditional plan approval. The Improvement and Stormwater Maintenance Agreements were forwarded to the developer by Attorney Magovern's office on January 17, 2018.

## 9. <u>UGI – Temple LNG Parking Land Development Plan</u>

Plans and documents meeting the conditions of the Supervisors conditional approval granted on December 1, 2016 have not been received. The final conditions of plan approval were forwarded to UGI's consultant by ARRO's correspondence dated June 9, 2017.

ARRO has contacted the developer regarding the status of this project and was informed the project is still active and they are pursuing outside agency approvals.

### 10. Infinity Capital Land Development Plan

ARRO conducted a review of the site improvements to date. Landscape (topsoil, trees, seeding, and mulch) items are required to be installed prior to our recommendation that the project improvements have been completed. To date an escrow release has not been requested by the developer. They are currently occupying the structure(s) under a temporary C of O issued by Kraft Code Services.

### 11. Ryder Land Development

ARRO provided the developer a punch list of items regarding the site improvements. To date there has not been a request for a final inspection or release of escrow.

### 12. <u>Harvest Subdivision</u>

As requested by the developer, ARRO completed a comprehensive review of curb ramps and driveway aprons within the development. A draft of the findings is being provided to the Township for review under separate cover.

An improvement inspection report is attached.

### 13. Willow Glen Subdivision

An improvement inspection report is attached.

### 14. Beechwood Subdivision

ARRO conducted site observations for all items listed by our punch list correspondence dated September 26, 2018. To date the remaining item to be verified is the cleaning and flushing of the storm sewer system.

One additional item not on the punch list that we became aware of is the lack of a street sign. Apparently the street sign was installed; however, it was struck and damaged by a vehicle.

## 15. Ashley Furniture Land Development Plan

We are waiting for a representative of Ashley Furniture to contact us that all site improvements have been completed and they are ready for a final inspection of the site improvements. The contractor is currently conducting final NPDES activities at the site.

## 16. General Engineering

New Enterprise, on behalf of EPA, placed a 1 ½" bituminous overlay on Wiley's Road along the EPA project area to the intersection of Ontelaunee Drive and on Ontelaunee Drive from Wiley's Road to SR 0073. An inquiry regarding the elevation of the paving at the intersection of Pillar Drive was made by a resident and the contractor indicated they would review and resolve the concern. A site visit for confirmation of the corrective actions will be conducted.

## 17. Road Projects

- a. New Enterprise Stone and Lime Co., Inc. commenced the 2018 Road Improvement Project on October 3<sup>rd</sup>. As of the preparation of this correspondence the remaining item to be completed was the trench restoration on the pipe crossing Gernants Church Road.
- b. A quote from AMS for conducting sealing operations on Redners Way is attached. The quote includes the cost per gallon for sealing Redners Way (200 Gallons \$4,890.00) and the cost per gallon for additional quantity of sealing necessary to provide one day of work (350 gallons \$6,597.00).
  - AMS has also provided a budget estimate of the corrective action conducted on Ontelaunee Drive (Twp. portion) which consisted of a slurry seal over the chip seal (Cape Seal). The Cape Seal is applicable when a roadway is experiencing cracking but shows limited signs of rutting or heavy oxidation. The other item, Ultra Thin Bonded Wearing Course, is visible on the PennDOT portion of Ontelaunee Drive and is typically used where there is minor rutting and oxidation of the roadway requiring sealing.
- c. ARRO will work towards preparing a grading plan and calculations of cut and fill volumes along Willow Creek Road to be used to obtain quotes to perform grading work in the spring of 2019.

## 18. Water System Engineering & Reporting

a. We forwarded a Disinfection Requirements Rule (DRR) siting plan to the water operator and testing agency for review and submission to PADEP.

## 18. Sanitary Sewer System Engineering

- a. A repair to the low pressure sanitary sewer force main lateral servicing 99 Berkley Road was observed.
- b. ARRO and Ontelaunee township staff continue to implement the surcharge and industrial waste permitting program utilizing revised parameters as discussed previously. The first round of permits was received and a list of responses has been forwarded to the Township. A draft letter for the late responses will be forwarded to the Township to be sent out.
- c. The Township was notified that a manhole on the Leesport Farmers Market is receiving infiltration. The township personnel contacted the owner regarding the problem and ARRO met with the owner. The owner has not had the chance to make the necessary repairs. The quick change in weather raised the priority of winterizing their facility. ARRO will follow up again on November 7. If no action has been initiated by this date, ARRO proposes a formal letter be sent to the owner officially addressing the necessity of the repairs and establishing a 60 day timeline.
- d. A violation notice was posted at 5309/5311 Pottsville Pike on Monday October 22, 2018. A letter written by the Township SEO stated that the owner was using a sump pump to pump sewage from their grinder pump unit into the field behind their property. When ARRO visited the property, the citation was given to one of the property owners, and an inspection of the property was conducted. The sump pump and hose had been removed, and the grinder pump was functioning as intended.

## 19. Sanitary Sewer Operations

- a. ARRO conducted services/activities identified under the Routine Operations scope of services outline in the Professional Services Agreement between Ontelaunee Township and ARRO.
- b. A definitive date has not been received from Kline Septic service to re-set pump #1 and install the new pump to replace #2 in the wet well at PS #8 as approved at the September Supervisors meeting.

WATER: September report was submitted

### **SEWER:**

A motion was made by Kenneth Stoudt and seconded by Gary Hadden to approve the proposal from Envirep Inc. to perform repairs to the impellers at Pump station #1 and #4 at a cost of \$10,730.80. Vote 3:0

### **SOLICITOR:**

A Public Hearing was held regarding rezoning of nine parcels along the east side of Rout 61 and south of Lakeshore Drive to IC.

A motion was made by Gary Hadden and seconded by William Klein to adopt Ordinance #2018-13 amending the zoning ordinance rezoning nine parcels along the east side of Route 61, on the south side of Lakeshore Drive currently within the A-1 and C district to now be zoned IC Industrial Commercial.
