As the warm weather approaches and we begin to consider summer backyard projects please be reminded that the Uniformed Construction Code (section 403.62) states **ANY**/ **ALL** prefabricated swimming pools

greater than twenty-four (24) inches in height require a Building Permit to be issued. Additionally, a Certificate of Occupancy must be obtained by the home owner **prior to the use of the pool.**



These requirements are for ANY/ALL swimming pools

regardless of whether they are purchased from a big box store or installed by a pool contractor.

Permits are available either at the Township Building or at <u>www.kraftcodeservices.</u> <u>com</u>. Once completed, the permit application should be submitted at the Township building along with the required \$50 non-refundable application fee payable to Ontelaunee Township.

Please contact Kraft Code Services at **610.775.7185** with any further questions.

Also, please note that a lot of things that you do around your home may or may not require a permit. Before any work is started, please check with the township office if a permit is required.

In most cases a permit is required for, but not limited to additions, decks, fences, pools, renovations, signs, driveway paving, concrete, roofing, electrical and plumbing work.

Our Building Inspector/Code Enforcement is handled by Kraft Code Services. Please visit their website at www.kraftcodeservices.com to obtain permit applications. Please submit your completed application with the application fee of \$50 for residential applications and \$150 for commercial applications to the township office. The application fee will be deducted from the permit fee.

In the event of an emergency, we utilize Swift Reach 911 call out service to inform our customers of any incidents which would affect our sewer or water customers. FOG stands for Fats, Oils and Grease, all of which can severely damage your sanitary sewer system. FOG includes animal and vegetable fats, as well as oils used to cook and prepare food. CAN IT. COOL IT. THROW IT AWAY.



WATER METERS:



Please note that it is your responsibility to keep the area to, in, and around the meter free of obstacles and encumbrances to permit safe and speedy access to the meter.

Although deemed "flushable" by their manufacturers, today's wet wipes actually do more harm than good when flushed down the toilet. Toilet paper is designed to disintegrate in our pipes and sewage systems, but wipes are not. They're typically made with synthetic materials, plastics or polyester, that won't break down. So even if they flush down your toilet, they end up clogging our sewers resulting in costly repairs.



As the snow melts and spring arrives, be sure to check your yard for any unforeseen issues. Inspect the sanitary sewer clean out caps confirming that they are securely in place and rise above the ground by a few inches to prevent infiltration. Infiltration is costly to everyone as it adds unnecessary flow to the sewer system resulting in additional fees. Look over your sidewalk and fix or repair any loose or uneven areas. Inspect your outside spigot(s) for cracks or damage from frost to prevent a potential leak.



Please note that our mailbox/afterhours drop box is located outside of the front doors of the Township Building. You may drop off payments at any time, just be sure it is received on or before the due date.

Dog Leash/Fecal Matter

All dogs must be restrained on any street or sidewalk. All fecal matter deposited by dogs must be cleaned up immediately.

Recycling information



Ontelaunee Township offers free Single Stream Recycling to our residents. Single Stream Recycling allows participants to place their recyclables in one container without sorting or separate bins.

The single stream dumpster is located behind the Township Building. Residents are welcome to drop their recyclables from dawn to dusk seven days a week. The area is monitored by security cameras. The Township does not provide pick-up or recycling containers.

Acceptable:

Aluminum cans, glass food & beverage containers (brown, green & clear), plastics (#1 thru #7), paper and cardboard. - In order to use all the space in the dumpster please smash or crush your plastic and cardboard.

Not Acceptable:

Pots, pans, aluminum foil, ceramic oven-ware, drinking glasses, window glass, mirror glass, light bulbs, Styrofoam, clay pots, plastic bags, foil type paper, paper towels, tissue paper.

Yard Waste -tree, shrubbery clippings may be taken to Berks Soil and Stone at 1 Belleman's Church Road, Leesport for recycling. 484-277-7901

<u>Weeds/grass – Don't forget</u> Weeds/grass must be maintained below 10" in height.



GRASS CLIPPINGS MUST GO OUT WITH YOUR TRASH



While mowing your lawn, no grass clippings or garden waste shall be deposited on any public property, sidewalk or street. This is a violation of our ordinance and is hazardous to motorcycle drivers, it is like driving on ice. In addition, the grass will flow into the storm drains when it rains and creates clogging of the drains.

Why is Stormwater a Problem?



In 2016, DEP labeled approximately <u>19,000 miles of rivers and streams in Pennsylvania</u> <u>impaired</u> for water supply, aquatic life, recreation, or fish consumption. Stormwater runoff pollution is one of the biggest reasons for this impairment.

Over the past 100 years, streets, parking lots, sidewalks, and roofs have been a steadily increasing

part of our communities as we've developed more and more of the landscape. As a result, rain that would otherwise soak into the ground instead rushes over these nonporous surfaces and into storm drains, which send it directly into rivers and streams.

Stormwater carries an enormous amount of pollution, including sediment, car oil, lawn fertilizers, pesticides, pet poop (and viruses and bacteria), and cigarette butts. As you might expect, this has many negative impacts on streams and rivers.

- Rivers are the source of our drinking water supply; when rivers aren't healthy, public health risks increase.
- Sediment harms aquatic life when it smothers macroinvertebrates and clogs spaces between rocks, destroying essential habitat for many species.
- Fertilizers stimulate excessive algae growth, causing algal blooms that remove oxygen from the water. Fish and other aquatic organisms can't exist in water with low dissolved oxygen levels.
- Bacteria and other pathogens can wash into swimming areas and create health hazards, making beach closures necessary.
- Debris—such as plastic bags, six-pack rings, and cigarette butts—washed into rivers can choke, suffocate, or disable ducks, fish, turtles, and birds.
- Household hazardous wastes like insecticides, pesticides, paint, solvents, and motor oil can poison aquatic life.
- Land animals and people can become sick or die from eating diseased fish and shellfish or ingesting polluted water.
- Because groundwater levels don't get fully replenished, springs and wells can go dry.
