Did you know that baby wipes may specify they are flushable, but they should not be put in our wastewater system? This also includes adult wipes, cleaning wipes (Clorox, Lysol), medical wipes, etc.

In fact, the only paper product that should be “flushed” is toilet paper. It is the only paper designed to break down as it travels through the wastewater treatment process.

WINTER WEATHER IS FAST APPROACHING

Before you know it the first snowflakes will be falling. It is hard to believe that summer is over and fall is upon us. After last year's winter, we are hoping that this years will be milder. It could be a very cold, brutal winter. You need to be prepared.

The road crews whether it be a Pa Dot driver or a township driver, they all need your patience and assistance during any snow or ice event.

Please remove the vehicles from the street to give the driver ample room to maneuver the plow.

If possible wait until the road has been plowed before clearing your driveway. There is no way to prevent snow from being pushed into driveways; however, shoveling snow to the right side of the driveway will minimize the amount of snow pushed back into the driveway by the plow. Please do not put any snow back onto plowed roadways.

All major thoroughfares will be done first. After the initial pass, the plow will return to widen the path.

The snow emergency routes are:

Calais Drive (entire length)

Verdun Drive (entire length)

Hannibal Lane

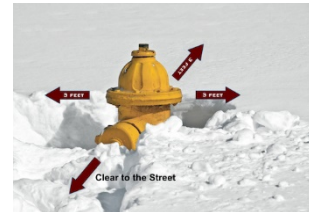
Nantucket Drive (entire length)

Indian Manor Drive from Belleman's Church Road to Gernant's Church Road

Gernant's Church Road from Indian Manor Drive to Loose Lane

Edinboro Lane (entire length)

The township supervisors are asking all residents with a fire hydrant in front of or on their property to **adopt the hydrant** during the winter months. Please shovel any snow that may accumulate around the hydrant. In a fire situation, seconds count and if the firefighters cannot find the hydrant or have to dig it out the lost time could result in catastrophic damage to your or your neighbor's home.



Prevent street flooding by clearing catch basins near your home to allow rain and melting snow to enter the drainage system.

All snow plows are angled the same way (to the driver's right) and will automatically push the snow that direction. It is impossible for the equipment operators to avoid pushing snow into cleared driveways and sidewalks. If you must clear your driveway prior to the completion of snow plowing, please keep in mind that the snow that is in front of the plow will unload wherever there is a cleared area. This is why snow is left in a cleared driveway as the street is plowed. Clearing an area on the side of the driveway from which the plow approaches will provide an area for the snow to unload before it reaches your driveway. This area needs to be at least five feet long and two to three feet wide.

It is unlawful to shovel, plow or snowblow any snow into the street or roadway.



Any property owner/tenant of every property fronting any street in the township is asked to remove from the sidewalks all snow or ice that has fallen within 24 hours after any snow event. Please have a path of 36 inches wide cleared.

Mailbox damage- the township is not responsible for any mailboxes that are located within the right of way, that are hit by snow, ice or snowplows.

It is our mission to make the streets passable and as safe for motorists as we can in the shortest period of time. Every storm is different and poses different challenges.

Thefts from Vehicles



We have experienced an increase in thefts from vehicles during the summer months, and would just like to remind our residents to make sure to:

- 1) Lock your car doors every time you park your car.
- 2) Keep expensive items such as laptops or purses out of sight by locking them in the trunk, hiding them under the seats, or covering these items with a blanket or other item so that it isn't readily apparent what they are to a casual observer.
- 3) Don't keep loose change, cell phones, or wallets in your cupholders where they are visible from someone looking in from outside.
- 4) And for those who have concealed firearm carry permits, a car doesn't make a good wallet. Please don't leave your gun unattended in your car.

These incidents are largely crimes of opportunity, and are usually initiated by the offender trying the door handles or looking into the vehicle to see if there is something worth the effort of breaking in. Following these basic steps will greatly help alleviate these crimes.

Our Building Inspector/Code Enforcement is handled by Kraft Code Services.

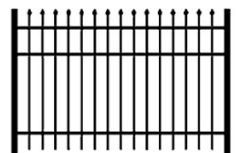

Please submit your completed application with the application fee of \$50 for residential applications and \$150 for commercial applications to the township office. The application fee will be deducted from the permit fee.



Sheds and other storage accessory buildings need to be placed in the rear yard. Sheds need to be placed ten feet from the side property line, five feet from the rear property line and ten feet from the home or other structure. However, if it is a corner lot or there is an easement of some type on your property, please contact Kraft Code Services at 610-775-7185 to discuss this further.

Fences may be placed on the property line, however, we suggest that you leave 1 to 2 feet on the side for maintenance of the fence.

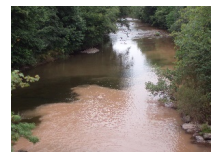
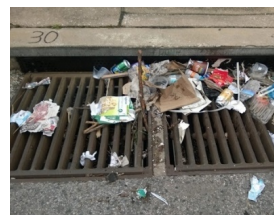
Stormwater – what you need to know

What is an MS₄ and where do MS₄ regulations come from?

The federal Clean Water Act (CWA) prohibits the discharge of pollutants into United States' waterways without an associated permit. Pennsylvania and its Department of Environmental Protection (PaDEP) regulate the discharge of pollutants through multiple programs in order to meet the runoff related requirements set forth by the federal CWA. The MS₄ program in particular regulates and permits discharges from municipal separate storm sewer systems (MS₄). An MS₄ is a system of stormwater conveyances (i.e. storm drains, pipes, ditches, and outfalls) that drain directly to waterways and are owned by a state, city, town, village, or other public entity.

Ontelaunee Township is a regulated MS₄, therefore the township is required to develop and implement a stormwater management program which incorporates six minimum control measures to reduce contaminated stormwater runoff:

- Public education and outreach
- Public involvement and participation
- Illicit discharge detection and elimination
- Construction site runoff control
- Post-construction stormwater management in new development and redevelopment
- Pollution prevention and good housekeeping for municipal operations and maintenance



Untreated or uncontrolled stormwater runoff is the leading cause of impairment to our local waterways and the number one cause of water pollution throughout the United States. Stormwater runoff can pick up debris, chemicals, dirt (yes, excess dirt in our waterways is a pollutant) and other pollutants then flow into a storm sewer system or directly into a lake, stream, river, wetland or coastal water, completely untreated. Pennsylvania's MS₄ program is ultimately aimed at protecting water quality through pollution reduction at a municipal level.
