# **EMERGENCY SERVICES REPORTS:**

#### **BUSINESS FROM FLOOR:**

Scott Cahill of Snyder Road was present to discuss the issue with the crop cannons and the load booms that happen every 13 minutes from 7 a.m. to 8 p.m. He stated he is trying to run a business and both himself and his workers have almost been trampled due to the cannons scaring his horses constantly. Supervisor Steingraber stated that the Board had a meeting with Mr. Hoffman regarding this issue. Mr. Hoffman had stated he has tried many different alternatives to scare the birds away from their crops, however the crop cannons seem to be the most effective way. Mr. Steingraber stated that the season will be coming to an end in the next 20 days or so, approximately around September 25 and then the cannons will cease. It was also stated that Mr. Hoffman has a right to farm. The board does not want to be put in a position where ethe AG's office would become involved. The developer who owns the land that Mr. Hoffman is leasing will be scheduling a meeting in the near future to discuss the project. This may be discussed at that time.

Ed Rohricht of Bewley Lane was present to discuss the issue with his neighbor and the noise and smell from their chickens. Mr. Rohricht discussed his family cannot be outside due to the noise from the chickens, rooster and turkey as well as the smell that is coming from their coop. He stated that most times when they have visitors, they cannot be outside due to these conditions. Mr. Rohricht also stated that the birds are kept in small areas which are inhumane. Mr. Rohricht requested that the ordinance not be adopted as it is but two acres remain necessary to have these birds. Mr. Rohricht stated that at the Zoning Hearing held at the end of August that the property owner stated they did not have a rooster, however, they do have a rooster as it is still making the noises.

Melissa Yoder, resident of the neighboring property, stated that they have had chickens for many years. They keep their animals, which are pets very clean. The animals are not inhumanly treated. They do not sell the eggs, if they have an abundance they give the eggs away. Solicitor Magovern asked Ms. Yoder if she had a

rooster and a turkey. She stated that they did. Solicitor Magovern wanted to be sure that Ms. Yoder knew she had to remove the rooster and the turkey as they are not allowed per the new ordinance, if it is adopted. In addition, since they continued the Zoning Hearing Board from August to the end of September, they could always ask for a variance to keep those two birds as well. If the variance is denied, they would have to remove both the rooster and the turkey from the premises.

# **Subdivisions and Land Development Projects**

- 1. **Printz Lot Annexation** Recommended action regarding the plan is listed on the agenda.
- 2. <u>Birch Hill Road (Perry Township Land Development)</u> Recommended action regarding the plan is listed on the agenda.
- 3. **Epting Tract Subdivision** Recommended action regarding the acceptance of an extension for action on the Preliminary Plan to December 4, 2025 is listed on the agenda.
- 4. **McIntosh Farms II** The patching and paving of the off-site portion of Ida Red Drive is scheduled for September 4<sup>th</sup>, 5<sup>th</sup> and 8<sup>th</sup>, weather permitting.

ARRO is conducting periodic observations of project improvements.

5. **Reitnouer Land Development Plan** - ARRO is conducting periodic observations of project improvements.

Discussion of the project landscape plantings is listed on the agenda.

6. <u>Crow Holdings Land Development (CHI)</u> - Right-of-way and easement documents were provided to the SVSD. It is our understanding that right-of-way, easement and improvement agreements remain to be reviewed and approved by the SVSD.

DCED concurred with the scope of work for the grant funds for signalization upgrades at the intersection of Ontelaunee Drive and Lakeshore Drive. The developer's consultant and representatives of Crow Holdings were informed that the bid document preparation would be by Bowman with review and administration of the bidding process conducted by ARRO on behalf of the Township.

- 7. <u>Miele Group Land Development</u> ARRO is conducting periodic observations of project improvements.
- 8. Schuylkill Valley School District (SVSD) No change since the last report.

The SVSD Consultant presented plans for discussion at the Planning Commission meeting held on July 17, 2025.

9. McIntosh Farms III Development – No change since the last report.

A request for a water will serve correspondence was received from the developer. This correspondence will be held until a definitive resolution to the water supply is arranged.

10. Pottsville Wholesale Development – No change since the last report.

A pre-submission meeting was held with the developer. The developer anticipates submitting a preliminary/final plan for the August Planning Commission meeting.

#### 11. Willow Creek Farms (Gaspari Tract) – No change since the last report.

An extension grant from the developer is listed on the meeting agenda for action by the Supervisors.

#### 12. General Engineering

- a. Orchard Lane Swale Arlan R. Wessner was informed of the acceptance of his quote in the amount of \$21,900.00 for armoring 525 feet of approximately 1,200 feet of roadside swale along Orchard Lane. To date no schedule for the work has been received.
- b. Orchard Lane/Canal Street M & A Excavation completed paving restoration. They did not utilize a sub-contractor as originally thought; therefore, additional paving above trench restoration at the curve on Canal Street to improve drainage was not conducted.

# c. SR 0073 Speed Study

Bowman completed the speed study from SR 0061 to the Township line on SR 0073 and provided copies to the Township under separate cover. The TE-101 form for signage changes and the periodic placement of a speed indicator sign was submitted to PennDOT. To date no response has been received from PennDOT.

d. Full Landscape and Tree Service Stormwater Plan/Sewer Plan/Sewer Planning Module

ARRO responded to an information request for the Component 3 Sewage Facilities Planning Module for the project.

e. <u>Stormwater Management Ordinance Exemptions</u> - If satisfactory to the Board of Supervisors the following exemptions will be utilized for an amendment to the Stormwater Management Ordinance.

- f. Stormwater Management Ordinance Applications have been received and reviewed or are currently being reviewed.
- g. <u>Orchard Lane Stormwater Management Plan</u> Revised Stormwater Management Plans and supporting documents were received and will be reviewed for the parking area on Orchard Lane and reported under separate cover.
- h. <u>TASA Project (MS4 PRP Implementation)</u> A reassignment of inspection personnel was required for the project prior to final award of the project.

The schedule has a Notice to Proceed being issued on October 20, 2025 and construction completion May 20, 2026.

i. <u>Bowers Road Project</u> - The contractor was directed to remove the silt sock from the project area. We have not verified that this has occurred.

- j. The owner of 108 Gernants Church Road provided the Township with an executed copy of the revised agreement prepared by Attorney Magovern's office. The agreement outlines costs and responsibilities for the repairs to Gernants Church Road and the commitment to reimburse the Township for the repairs.
- k. Road Opening Permits applications have been received from Frontier Communications for the installation of communication cable, pedestals and junction boxes within the Harvest, Beechwood and Willow Glen developments and Wingco Lane, Osterling Drive and Margaret Street. Applications fees and escrow funds have been requested from the applicant. A meeting with the applicant is scheduled for September 10<sup>th</sup> at 10:30 a.m. with the applicant.
- I. The annual MS4 Report is being prepared for submission prior to the due date of September 30, 2025.
- m. The meeting agenda contains an item regarding the opening, review and action on the bids requested for the roof mounted solar panels for the Township building.

#### 13. Water System Engineering & Reporting

- a. The Memorandum of Understanding for the proposed RAWA upgrades to the Ashley Water Booster Pump Station to address existing water pressure concerns and future needs within Ontelaunee Township was executed and forwarded to RAWA.
- b. ARRO requested quotes for the installation of an air release valve on Ide Red Drive. Quotes are due September 4<sup>th</sup> before 6 p.m.
- c. ARRO responded to a citizen inquiry regarding Nitrate/Nitrite reporting listed in the Consumer Confidence Report (CCR).
- d. ARRO will coordinate PADEP approval of testing at the auto flusher on Wingco Lane in lieu of the Berks Medical facility.

# 14. Sanitary Sewer System Engineering

- a. The following Industrial permitting documents are under review.
  - i. Hazardous Waste Permit submission for the Reitnouer facility
  - ii. Materion Pre-treatment Upgrade
  - iii. Cambridge Lee IU permit.
- b. The Township and ARRO personnel will be meeting on September 10<sup>th</sup> regarding the status versus requirements of the Township Industrial User permitting program and surcharge testing.
- c. The Township staff and ARRO researched lateral information related to 241 Gernants Church Road. All documents in our possession lead to the belief that no lateral for the parcel exists; however, the owners consultant professes a lateral does exist.

d. ARRO was authorized at the July Supervisors meeting to schedule a meeting with PADEP, RAWA and Attorney Magovern regarding the exposed sewer and water pipes in Willow Creek. To date, we have not scheduled the meeting.

# 15. Water System Operations (ARRO Water Services)

Additional flushing by the Township staff resulted in adequate chlorine residuals in response to an inadequate test result received from MJ Reider.

# 16. Sanitary Sewer Operations (ARRO Water Services)

Services/activities were conducted as identified under the Routine Operations scope of services outlined in the Professional Services Agreement between Ontelaunee Township and ARRO.

- a. Following a request by the operators, the removal of grease from pump stations is being coordinated by Township personnel. The addition of Proka for grease reduction will once again be implemented on a regular basis.
- b. AWS personnel reported an alarm for the PS #7 generator related to it not starting properly during the weekly exercising schedule.

A motion was made by Josh Steingraber and seconded by Jeremy Hoagland to accept the review extension for the Epting Tract Preliminary Plan until December 4, 2025 as provided by the developer. Vote 3:0

A motion was made by Chuck Grebloski and seconded by Jeremy Hoagland to approve Reitnouer escrow release #3 in the amount of \$1,173,533.15. Vote 3:0

The Municipal building solar roof project bids were received and read as follows:

Paradise Solar \$475,000.00 Spotts Brothers \$324,350.00

At this time the topic was tabled for the Solicitor and Engineer to review the bids.

Discussion was held regarding the planting of vegetation along Route 73 for the Reitnouer project. A motion was made by Jeremy Hoagland and seconded by Chuck Grebloski to approve the request to hold off on planting the vegetation until after the road project at 73 and Ontelaunee Drive is completed and that a bond will be held until such time as all the trees have been planted. Vote 3:0

A motion was made by Jeremy Hoagland and seconded by Chuck Grebloski to approve the signing of an agreement with the property owner of 108 Gernants Church Road detailing repairs to the roadway that occurred during their driveway paving. Vote 3:0

Discussion was held regarding Ontelaunee Drive between Kindt Corner Road and Moser Lane, the hill in the area becomes extremely slick when it rains or snows. Questions were raised as to how to fix the issue. This is a state portion of Ontelaunee Drive. Mr. McMullen will contact PA DOT to discuss a skid resistant surface or any other remedies that could help alleviate this problem.

At this time a Public Hearing was held regarding the amendment to Chapter 27 regarding keeping of chickens, ducks and turkeys. Since everyone had expressed their concerns at the beginning of the meeting under Business from the floor, there were no additional comments.

A motion was made by Chuck Grebloski and seconded by Josh Steingraber to adopt Ordinance #2025-3 amending Chapter 27 of the code of ordinance entitled Zoning to create regulations for the accessory keeping of chickens, ducks and turkeys. Vote 3:0
